## TERMS AND CONDITIONS

1. Prior year sponsors have right of first refusal but must notify SAVTA of their decision within 30 days of receiving the Sponsorship application and must be confirmed by SAVTA. Sponsor agrees to pay above indicated sponsorship amount as determined by SAVTA. Payment in full is due with the application. SAVTA reserves the right to withdraw the sponsorship if payment is not received within thirty (30) days of receipt of the above application. Acceptance of this application by SAVTA creates a binding contract. All sponsorship payments received by SAVTA are non-refundable.
2. SAVTA and the Sponsor agree that the activities contemplate by this Agreement are limited and shall be conducted consistent with SAVTA's status as a no-profit organization exempt under Section (c)(6) of the Internal Revenue Code. Nothing in this Agreement shall be construed to imply SAVTA's endorsement of the Sponsor or any of its products or services.
3. Sponsor agrees to indemnify and hold SAVTA harmless, including attorney fees from and against any charges, claims, suits, liabilities, costs, judgments or settlements of any kind arising out of Sponsor's activities pursuant to this Agreement.
4. Sponsor warrants that all material distributed by Sponsor will not violate the laws of the United States or of any State, or any proprietary rights of others, including, but not limited to, patents, trademarks, copyrights, and domain names, and that all content that is distributed by Sponsor is owned or lawfully distributed by Sponsor.
5. It is understood that SAVTA may terminate this Agreement at any time in its sole discretion. Upon such termination, SAVTA shall refund Sponsorship fees received by SAVTA prior to the termination. Such refund is Sponsor's sole remedy in the event of termination, and Sponsor agrees not to assert any other claims against SAVTA.
6. This Agreement shall be governed and construed in accordance with Texas law. All disputes arising under this Agreement shall be resolved by binding arbitration under the rules of the American Arbitration Association to take place in Dallas, Texas.
